

## FAM BAM COMPETITION

### TERMS AND CONDITIONS

1. This competition (**Competition**) is conducted by Barwon Timber & Hardware Pty Ltd (ABN 39 006 592 525) of 50 Fellmongers Road, Breakwater, 3219 (**Barwon Timber**).
2. Entry to the Competition constitutes acceptance of these terms and conditions (**Conditions**).
3. The Competition is only open to Eligible Entrants. An "**Eligible Entrant**" is an individual who, at the time of entry:
  - (i) holds an account with Barwon Timber, or who is a director, shareholder or employee of a business that holds an account with Barwon Timber;
  - (ii) follows Barwon Timber's Instagram and/or Facebook page;
  - (iii) is a resident of Australia aged 18 years or older (13, with guardian / parent consent);
  - (iv) is not an employee of Barwon Timber or any of its related corporations or suppliers; and
  - (v) is not a spouse, de-facto spouse, parent, child or sibling of an employee of Barwon Timber.
4. Entries from persons who are not an Eligible Entrant are excluded from the Competition and will not be considered.
5. The Competition commences on 19/08/2019 at 00:01 AEST/AEDT and closes on 4/11/2019 at 23:59 AEST/AEDT (**Entry Period**). All entrants must ensure that their entry is received by Barwon Timber during the Entry Period. Barwon Timber takes no responsibility for any late or misdirected entry or for any delays or failures in any telecommunications service or equipment.

Entries must be made by an Eligible Entrant uploading a photo to Instagram during the Entry Period that (i) features Barwon Timber merchandise; (ii) references Barwon Timber; and (iii) is posted with the hashtag #barwonfambam. Barwon Timber may at its discretion allow entries to be submitted via its Facebook page.
7. Any entry which is considered by Barwon Timber in its absolute discretion to be defamatory, offensive, in poor taste or not in accordance with these Conditions will not be considered and will be excluded from the Competition.
